BY CONSENT THE COURT ORDERS THAT:

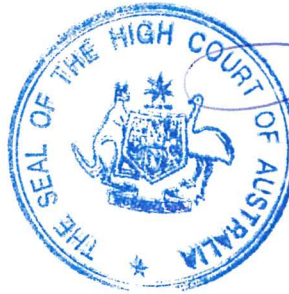

6. On or before 4pm on 17 April 2025, the Defendant file and serve their submissions addressing the questions of law stated in the special case.
7. On or before 4pm on 24 April 2025, any intervener in support of the Defendant or in support of neither party file and serve submissions addressing the questions of law stated in the special case.

8. On or before 4pm on 30 April 2025, the Plaintiffs file and serve their submissions in reply.
9. On or before 2 May 2025, the Plaintiffs file and serve the Joint Book of Authorities.
