

17 and 29 December 2003	Expert consultants engaged by the Miner, Mine Subsidence Engineering Consultants (MSEC), predict subsidence levels from mining of, inter alia, longwall panels 29-33. MSEC predict subsidence of the ground where the pipeline crosses Mallaty Creek commencing with the mining of longwall 30.	SOAF [28] AB #
11 February 2004	Expert engineering consultants (Worley) engaged by the Miner to interpret and model the effects of the subsidence predicted by MSEC advise that the anticipated pipeline stress at Mallaty Creek resulting from the predicted cumulative subsidence from longwalls 30 and 31 was within acceptable levels but that the anticipated stress from predicted cumulative subsidence from longwalls 30-32 exceeded acceptable levels and mitigation works were required.
